Mr. Arkin obtained his LLM (ADR, 2002) from Osgoode Hall Law School, and his BA (1969) and LLB (1972) from the University of Manitoba. He was called to the Manitoba Bar (1973) and the Ontario Bar (1995). As Mediator with the Financial Services Commission of Ontario ("FSCO") since 2000, he was responsible for Accident Benefit Motor Vehicle Mediation for the Ontario Government. Mr. Arkin conducted over 7400 mediations as a Government Mediator, a Roster Mediator with the Ontario Mandatory Mediation Program - Toronto and Ottawa, a Roster Mediator with the Automobile Injury Mediation Office in Winnipeg, and in his private mediation practice.

Mr. Arkin was formerly associated with Rye & Partners in Toronto, and the Winnipeg law firms of Duboff, Edwards, Haight & Schachter; Oliver, Derksen, Arkin; Thompson, Dorfman, Sweatman; and Aikins, MacAulay & Thorvaldson. He also served as ADRIO's member on the York University Dispute Resolution Advisory Committee ("DRAC") for a 3 year period. He has coached Osgoode Hall Law School students in mediations held in Ontario's Small Claims Court, and has participated in a program for York University Dispute Resolution Student Observers at FSCO, 2009 and 2010.

Mr. Arkin has expertise in the areas of insurance, personal injury & administrative law as a Government Mediator. He is also experienced in corporate/commercial law, real estate (commercial & residential), wills & estates, elder law, employment law, and not-for-profit law. While in active practice Mr. Arkin attained a "bv" ranking with Martindale Hubbell for both Ontario and Manitoba.

Mr. Arkin served as a part-time lawyer member on the Consent & Capacity Board of Ontario (Ontario's mental health review board) for a three year term from February 10, 2006 through February 9, 2009. He was a panelist on the issue of "The Need for Impartiality and Cultural Sensitivity" for the Inaugural Fair Hearing Conference presented by Federated Press in Toronto, September 29 and 30, 2010. He was Co-Chair and panelist for the second Fair Hearing Conference held in Toronto on September 12 and 13, 2011 and the seventh conference April 21 and 22, 2015.
